

## RESOLUTION 12-101

### A RESOLUTION OF THE CITY OF WESTFIELD ADOPTING AN AMENDMENT TO THE COMPREHENSIVE PLAN

**WHEREAS**, the Council has the duty and authority to approve any and all changes to the Westfield-Washington Comprehensive Plan; and,

**WHEREAS**, it has become necessary to amend the Comprehensive Plan by the addition of a new and revised Zone Improvement Plan which was adopted and certified by the Westfield-Washington Advisory Plan Commission (“APC”) on April 2, 2012.

**NOW, THEREFORE, BE IT RESOLVED** by the Westfield City Common Council meeting in session as follows:

**Section 1.** The Council has reviewed the amendment to the Comprehensive Plan regarding the new Zone Improvement Plan and certified by the APC and hereby approves the same.

**Section 2.** This Resolution shall be in full force and effect immediately and remain in effect until further action by the Council.
