

## ORDINANCE 12-33

### ORDINANCE FOR ADDITIONAL APPROPRIATION

**WHEREAS**, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, it is the duty and the responsibility of the Council to maintain the fiscal integrity of the finances of the City, and

**WHEREAS**, sometimes becomes necessary to appropriate additional funds within the approved budget as contemplated and authorized under I.C. 36-4-7-8 to maintain that fiscal integrity.

**NOW, THEREFORE, BE IT ORDAINED** by the Westfield City Common Council meeting in session as follows:

**Section 1.** That the additional appropriation of Ten Thousand dollars (\$10,000.00) received by grant from the Hamilton County Convention and Visitors Bureau is hereby authorized to be transferred and appropriated as indicated below.

**Section 2.** That said amounts shall be distributed as follows:

\$5,844.00 to: Park Impact Fee Fund 204001349

\$4,156.00 to: Grant Fund 552001349

**Section 3.** This Ordinance shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All ordinances or parts thereof that are in conflict herewith are hereby ordered repealed.
