

## ORDINANCE 12-34

### ORDINANCE TO AMEND OF INTERSECTION FROM TWO WAY TO FOUR WAY STOP

**WHEREAS**, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, it is the duty and the responsibility of the Council to authority and duty to identify and remedy real and possible dangerous intersections within the City and to facilitate the orderly flow of traffic within the City through the use of traffic control devises and signage within the city limits, and

**WHEREAS**, in order to address these concerns and possible hazards the traffic control signage at a certain intersection should be changed to more adequately reflect the current driving patterns.

**NOW, THEREFORE, BE IT ORDAINED** by the Westfield City Common Council meeting in session as follows:

- Section 1.** That the intersection of 169<sup>th</sup> Street and Gray road within the City shall be changed to become a Four Way Stop.
- Section 2.** That Sec. 58-348 and all related Tables shall be amended to the pursuant to this Ordinance. The signage shall be changed no sooner than two weeks from the publication of this Ordinance.
- Section 3.** This Ordinance shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All ordinances or parts thereof that are in conflict herewith are hereby ordered repealed.
