

ORDINANCE 08-51

**AN ORDINANCE OF THE CITY OF WESTFIELD SAFEGUARDING
STUDY AREA FOR FUTURE REDEVELOPMENT AND PUBLIC
ENHANCEMENTS**

WHEREAS, the City of Westfield, Indiana, hereinafter referred to as “City”, is governed by its duly elected Common Council (“Council”) and Mayor and has the authority and responsibility to adopt, maintain and amend the Westfield-Washington Township Zoning Ordinance (hereinafter, “Ordinance”) in Westfield and receive and process platting for subdivisions, location improvement permits; and,

WHEREAS, the City has been notified of a public citizens group that wishes to study and make recommendations on improvement and/or redevelopment in a localized small area of the City that would be beneficial to the entire City and surrounding areas; and,

WHEREAS, to allow continued sporadic and unplanned development would impede this process and create an ever changing landscape upon which to comment and plan by this Citizens group, and;

WHEREAS, in the best interests of the citizens within the City, the following temporary measure is necessary and beneficial to the entire City.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

SECTION I. That effective immediately, the City will not be accepting requests for subdivision plats, site development improvement permits, or any other petitions to change the current uses and development presently in place within the area described by Exhibit “A” attached hereto and incorporated by reference herein..

SECTION II. That this Ordinance shall be effective upon passage and shall remain in effect for 90 days after adoption.




