

ORDINANCE 09-10

ORDINANCE TO ADOPT FEE SCHEDULE FOR THE WESTFIELD PARKS DEPARTMENT

WHEREAS, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

WHEREAS, the Council has the duty and authority to maintain clear, current and written fee schedules for those items and services purchased by persons at the Westfield Parks Department; and,

WHEREAS, said fee schedule must be adopted and maintained for the benefit of the fiscal integrity of the Westfield Parks Department.

NOW, THEREFORE, BE IT ORDAINED by the Westfield Common Council meeting in session as follows:

Section 1. That the City hereby adopts the fee schedule for the Westfield Parks Department evidenced by Exhibit “A”, attached hereto and incorporated by reference herein.

Section 2. This Ordinance shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. If any portion of this Ordinance is found be invalid it shall not operate to invalidate any remaining portions. All ordinances or parts thereof that are in conflict herewith are hereby ordered repealed.
