

ORDINANCE 09-12

AN ORDINANCE ADOPTING CERTAIN FEES REQUIRED BY THE WESTFIELD POLICE DEPARTMENT

WHEREAS, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

WHEREAS, The City maintains and operates the Westfield Police Department for the safety and protection of the public; and,

WHEREAS, it is the duty and the responsibility of the Council to consider and adopt legislation outlining the fees that are required for the orderly and efficient operation of the Westfield Police Department; and,

WHEREAS, this Council finds that there is a need to adopt a schedule of fees for use by the Westfield Police Department and to allow for the necessary amendment thereof.

NOW, THEREFORE, BE IT ORDAINED by the Westfield City Council meeting in session as follows:

Section 1. That upon review of the schedule of fees, attached hereto as Exhibit “A” and incorporated herein, the Council finds that the fees are justified, reasonable and necessary for the responsible operation of the Westfield Police Department.

Section 2. That the Westfield Police Chief is hereby authorized to charge and collect the fees as adopted and to create any and all policies necessary to carry out the fair and equitable application of the fees to the general public.

Section 3. That any necessary amendments to the fee schedule outlined on Exhibit “A” may be accomplished by a duly adopted resolution by the Council.

Section 4. This Ordinance shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All ordinances or parts thereof that are in conflict herewith are hereby ordered repealed.
