

WESTFIELD CITY COUNCIL, August 10, 2009

The Westfield City Council met in regular session Monday August 10, 2009 at the Westfield City Hall. Members present were Rob Stokes, Steve Hoover, Tom Smith, Bob Horkay, Bob Smith, Ken Kingshill and John Dippel. Also present were Mayor, Andy Cook, Clerk Treasurer, Cindy Gossard and Legal Counsel, Brian Zaiger. Mayor Andy Cook called the meeting to order at 7:00 p.m.

APPROVAL OF MINUTES:

Steve Hoover made the motion to approve July 13, 2009 minutes as amended. John Dippel seconded. Vote: Yes-7; No-0. Motion carried.

MISCELLANEOUS BUSINESS/SPECIAL RECOGNITION:

Proclamation:

Children's Vision & Learning Month

Mayor Cook introduced Jill Thomas. He then presented the Proclamation of the month of August being Children's Vision & Learning month in the City of Westfield.

Hamilton County Emergency Management Agency Awareness

Mayor Cook stated Westfield is working with the County to make the Hamilton County Emergency Management. He went on to explain that this would make a more efficient program.

David Bice introduced himself and explained the definition of the Emergency Management Agency Awareness.

Numa Festival

Teresa Skelton announced that this year's arts and cultural event Numa will be held Saturday September 19, 2009. The event will take place between the hours of 10:00AM and 10:00PM. She described the location of the event as well as what activities would be taking place. On behalf of the Numa committee she thanked the City of Westfield for their cooperation and support with logistics as well as public safety.

Mayor Cook gave a brief update of the Sports Complex Facility. He also announced that Phase 1 is finished and Phase 2 had begun.

Ordinance 09-15: Amendment to Ordinance 09-04 Solicitor's Permit
First Reading – August 10, 2009
Second Reading – August 24, 2009
Adoption Consideration – August 24, 2009

Jennifer Miller presented this item explaining some of the changes and modifications to our current Solicitor's Permit. She explained these changes originated at the Clerk-Treasurer's office where the permits are considered. She explained that Deputy Clerk-Treasurer Teresa Skelton was available to answer administrative questions.

President Kingshill questioned the ordinance prohibiting businesses outside of the City of Westfield not having the opportunity to canvas promotional material without a permit.

Steve Hoover wanted to be cautious of too many changes to the proposed ordinance. He would like to see quality businesses encouraged to have a Westfield location with a building permit or the nominal fee of a solicitor's permit.

Tom Smith asked how this affects City events and the vendors of those events. Ms. Skelton explained that any vendor at a City wide event would have to meet the requirements of that event.

John Dippel shared in President Kingshill's concern with outside businesses and also would like to keep the name "peddler" out of the ordinance.

It was determined that these suggestions from the Council would be discussed and this ordinance will be brought back to the Council next meeting for consideration.

James Crawford gave an update of the Grand Junction Economic Development Area.

After a brief description it was determined that this resolution could be considered on the first reading.

Bob Horkay made a motion to approve Resolution 09-08 as presented. Steve Hoover seconded. Vote: Yes-6; No-0; Abstain-1 (Rob Stokes). Motion carried.

CITY COUNCIL COMMENTS:

Tom Smith expressed his appreciation to everyone that helped with the Grand Junction Derby the past weekend.

Steve Hoover complimented the Grand Junction Derby committee for their hard work.

The rest of the Council echoed their appreciation.

Bob Horkay announced that the Bridgewater PUD will appear for a public hearing at the Advisory Plan Commission meeting August 17, 2009.

Tom Smith announced that Saturday September 26, 2009 the “Heart and Soul” clinic tentatively is holding a grand opening.

MAYOR COMMENTS:

The Grand Junction Design team had a two day session.

The City Engineers are doing a survey of Union Street.

The Public Works Department reconstructing seven curbs and gutters to meet ADA requirements.

The portion of the Monon trail up to 161st Street should be complete by September 9th of this year.

INDOT is doing a safety analysis and some improvements are taking place such as limiting left turn at 169th Street.
