

ORDINANCE 09-14

CUMULATIVE CAPITAL IMPROVEMENT FUND
ADDITIONAL APPROPRIATION

WHEREAS, the City of Westfield Common Council (“Council”) has the responsibility and duty to maintain appropriate balances within the City’s budget and to appropriate funds as necessary; and

WHEREAS, the City maintains the cumulative capital improvement fund for the uses stated under Indiana law and the ordinances of the City of Westfield; and

WHEREAS, the Council has determined that an additional appropriation is necessary for the benefit of the citizens of the City of Westfield.

NOW THEREFORE BE IT ORDAINED THAT:

1. The City Council of Westfield, Hamilton County, that for the expenses of the taxing unit, the following additional sums of money are hereby appropriated out of the funds named and for the purposes specified, subject to laws governing the same:

2. Said funds shall only be disbursed pursuant to the procedures and policies outlined by Statutes of Indiana, the Ordinances of the City of Westfield and the Indiana Department of Local Government and Finance.
3. This Ordinance shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All Ordinances or parts thereof that are in conflict herewith are hereby ordered repealed. Any portion of this Ordinance later deemed invalid shall not operate to invalidate the remaining portions.
