

## RESOLUTION 11-08

### A RESOLUTION OF THE CITY OF WESTFIELD TO ADOPT A PARKS MASTER PLAN

**WHEREAS**, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, the Council has the duty and authority to recognize and authorize policies and long range plans that provide for responsible and positive growth of the Westfield Parks and Recreation Department; and,

**WHEREAS**, the Council having been duly advised in the Westfield Parks Master Plan, believes that adoption of the same is beneficial for the citizens of the City.

**NOW, THEREFORE, BE IT RESOLVED** by the Westfield City Common Council meeting in session as follows:

**Section 1.** The Council now formally adopts the Westfield Parks and Recreation Department Master Plan, attached hereto as Exhibit “A” and incorporated herein.

**Section 2.** This Resolution shall be in full force and effect immediately and remain in effect until further action by the Council. All acts undertaken to create the Westfield Parks and Recreation Department Master Plan are hereby ratified.
