

Setter's Run Roadway Vacation


Blocks 'A' and 'J' as described in Setter's Run Sections One and Two respectively are platted and recorded subdivisions in the Recorders Office of Hamilton County. These Blocks contain the existing roadway to be vacated. The lots adjoining these Blocks do not have any access rights to the existing roadway due to the platted 5 feet non-access easement. The removal of this roadway will not limit the access to any lots in Setter's Run Subdivision Sections One or Two.

The property deeded to Barbara DeNoon recorded as Instrument Number 9809850685 in the Recorders Office of Hamilton County, Indiana, is subject to all legal highways, rights-of-way and easements. These rights-of-way will be abandoned when the roadway is removed and all underling rights will revert back to the current property owner(s). Barbara DeNoon's property now has access from Setter's Run Section Three along Inez Setter's Lane.

Setters Place Subdivision east line has no access or rights-of-way to the roadway to be removed and vacated.
