

ORDINANCE NUMBER 07-25

AN ORDINANCE OF THE TOWN OF WESTFIELD ESTABLISHING CONTINUITY IN TRANSITION TO CITY OF WESTFIELD

WHEREAS, the Town of Westfield, Indiana, hereinafter “Town”, is a duly formed municipal corporation within the State of Indiana and governed by the Town Council, hereinafter “Council”, has enacted the appropriate legislation to convert the Town of Westfield into the City of Westfield effective January 1, 2008 and,

WHEREAS, it is in the best interests of the citizens of the Town/City to have the transition take place without interruption of services or loss in a clear chain of communication and control during this transition; and,

WHEREAS, in an effort to facilitate the transition and to avoid any interruption for the public and after being fully advised in the matter.

NOW THEREFORE BE IT ORDAINED BY THE WESTFIELD TOWN COUNCIL THAT:

SECTION I. That until the appointments can be made for Department Heads for the new City of Westfield, those persons holding the position with the Town of Westfield shall continue in their capacities until reappointed or replaced as soon as the appropriate appointing body may exercise its discretion.

SECTION II. That the City of Westfield is hereby named to be the successor in interest of any and all ordinances, resolutions, contracts, debts, encumbrances, duties or obligations undertaken by the Town of Westfield.

SECTION III. That all acts undertaken by the Town of Westfield, its boards, commissions, committees shall be deemed to have been undertaken by the City of Westfield.

SECTION IV. That the members of any and all Town boards, commissions or committees shall serve in their capacity until appointments replacing those members have been executed by the appropriate appointing authority.
