

RESOLUTION 08-10

RESOLUTION ESTABLISHING THE PROCEDURE FOR REZONE PETITIONS

WHEREAS, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

WHEREAS, it is the responsibility of the Council to create and codify policies and procedures for the orderly flow of rezoning petitions for property within the zoning jurisdiction of the City, and

WHEREAS, it is the desire of the Council to address the needs of the zoning staff, developers and the general public as it concerns the process to be followed.

NOW, THEREFORE, BE IT RESOLVED by the Westfield City Common Council meeting in session as follows:

- Section 1.** That all proposals, petitions and requests to amend any portion of the zoning maps or text on any property within the zoning jurisdiction of the City of shall be presented to the Council in a regular meeting prior to being referred to the Advisory Plan Commission.
- Section 2.** No petition shall be referred to the Advisory Plan Commission for public hearing until first presented to the Common Council.
- Section 3.** This Resolution shall not be construed to prevent the Community Development staff from initiating map or text change proposals directly to the Advisory Plan Commission.
- Section 4.** This Resolution shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All ordinances or parts thereof that are in conflict herewith are hereby ordered repealed.
