

ORDINANCE 09-25

ORDINANCE OF THE CITY OF WESTFIELD, INDIANA REPEALING ORDINANCE 08-19 (Southeast Area 2)

WHEREAS, the City of Westfield is governed by its duly elected City Council (“Council”); and,

WHEREAS, the Council has the authority to enact, amend and repeal ordinances they have duly adopted by the Council; and,

WHEREAS, the Council had previously adopted Ordinance 08-19 annexing certain areas in Washington Township commonly known as Southeast Area 2; and,

WHEREAS, at times it becomes necessary and prudent to repeal ordinances that have been duly and properly enacted for the benefit of the citizens of the City of Westfield.

NOW, THEREFORE BE IT ORDAINED BY THE WESTFIELD CITY COUNCIL THAT:

Section 1. That Westfield City Ordinance 08-19 is hereby repealed and of no effect.

Section 2. That any and all actions taken in the adoption of Ordinance 08-19 and its repeal are hereby ratified.

Section 3. This Ordinance shall be in full force and effect in accordance with Indiana Law, upon its passage by the City Council, its publication in accordance with law, and upon the passage of any applicable waiting period, all as provided by the laws of the State of Indiana. All ordinance or parts thereof in conflict herewith are hereby repealed.
