

## RESOLUTION 10-01

### RESOLUTION TO AMEND WESTFIELD CITY PARK FEES

**WHEREAS**, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, the Council has the duty and authority to maintain current fees for the management and maintenance of the facilities located within the Westfield City Parks; and,

**WHEREAS**, it has come to the attention of the Council that an amendment to the current fee structure is necessary.

**NOW, THEREFORE, BE IT RESOLVED** by the Westfield City Common Council meeting in session as follows:

- Section 1.** That pursuant to Ordinance 09-10, the City hereby adopts by this Resolution the changes to the fees charged by the Westfield Parks Department as outlined by Exhibit “A”, attached hereto and incorporated by reference herein.
- Section 2.** The Westfield Parks Department is hereby authorized to institute these changes immediately.
- Section 3.** This Resolution shall be in full force and effect immediately, all acts necessary in the creation of this manual and amendments thereof are hereby ratified.
