

## RESOLUTION 10-03

### A RESOLUTION OF THE CITY OF WESTFIELD DELETING INACTIVE FUND ACCOUNTS FROM CITY FINANCES

**WHEREAS**, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, the Council has the duty and authority to maintain and allocate funds as necessary from the duly adopted budget to maintain the fiscal integrity of the City and maximize efficiency; and,

**WHEREAS**, maintain efficient management of the City’s finances it has become necessary to delete certain inactive fund accounts.

**NOW, THEREFORE, BE IT RESOLVED** by the Westfield City Common Council meeting in session as follows:

**Section 1.** That the Clerk-Treasurer is hereby authorized to delete the following inactive funds accounts of the City of Westfield.

- a) Fund 240 previously used for Police Seminar Training.
- b) Fund 307 previously used for G.O. Bonds.
- c) Fund 311 previously used for 2005 Parks G.O. Bonds.
- d) Fund 507 previously used for Capital Improvement.

**Section 2.** All said funds are and have been inactive and contain no balances to be transferred to active fund accounts.

**Section 3.** This Resolution shall be in full force and effect immediately and remain in effect until further action by the Council.
