ORDINANCE 09-27

ORDINANCE OF THE CITY OF WESTFIELD, INDIANA REPEALING ORDINANCE 08-26 (Southeast Area 9)

WHEREAS, the City of Westfield is governed by its duly elected City Council (“Council”); and,

WHEREAS, the Council has the authority to enact, amend and repeal ordinances they have duly adopted by the Council; and,

WHEREAS, the Council had previously adopted Ordinance 08-26 annexing certain areas in Washington Township commonly known as Southeast Area 9; and,

WHEREAS, at times it becomes necessary and prudent to repeal ordinances that have been duly and properly enacted for the benefit of the citizens of the City of Westfield.





NOW, THEREFORE BE IT ORDAINED BY THE WESTFIELD CITY COUNCIL THAT:

All ordinance or parts thereof in conflict herewith are hereby repealed.






