

ORDINANCE 10-13

ORDINANCE OF THE CITY OF WESTFIELD TO AMEND ORDINANCE 10-06

WHEREAS, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

WHEREAS, it is the duty and the responsibility of the Council to maintain the fiscal integrity of the finances of the City by maintaining appropriate fees for services performed by the City and to foster economic activity and growth by creating incentives and lessening obstacles for future development , and

WHEREAS, the Council from time to time may find it necessary to amend previously adopted ordinances to assure that the desired purposes are carried out as contemplated by the Council; and,

WHEREAS, the current sewer fees have been set and amended by ordinances 03-25 and 06-43 and the current water fees have been set and amended by ordinances 03-24, 06-44 and 10-06; and,

WHEREAS, to clarify and better direct the Westfield Public Works and the Department of Community Development in the administration of Ordinance 10-06 the Council finds it necessary to amend 10-06.

NOW, THEREFORE, BE IT ORDAINED by the Westfield City Common Council meeting in session as follows:

Section 1. The Council now finds that an amendment of Ordinance 10-06 is necessary to properly direct the Westfield Department of Public Works in the administration of Ordinance 10-06.

Section 2. That the first paragraph of Section 2 of Ordinance 10-06 shall be amended to the following:

“That the following fees and charges currently being charged within Washington Township, Hamilton County, Indiana by the City of Westfield in, shall be amended as outlined below for the fees currently assessed or later to be amended”.

Section 3. This Ordinance shall be in full force and effect in accordance with Indiana Law, upon its passage by the City Council, its publication in accordance with law and upon the passage of any applicable waiting period, all as provided by the laws of the State of Indiana. All ordinances or parts thereof in conflict herewith are hereby ordered amended or repealed. All acts taken pursuant to the adoption of this Ordinance are hereby ratified.
