Petition History

On May 9, 2011 the City Council forwarded the Westfield Thoroughfare Plan Addendum (the "Addendum") to the Advisory Plan Commission (the "APC"). The Addendum was before the APC at the June 6, 2011 meeting for public hearing. It was approved by the APC at its June 20, 2011 meeting.

Procedural

- Requests for Addendums to the Westfield-Washington Township Comprehensive Plan (the "Comprehensive Plan") are required to be considered at a public hearing in accordance to with Ind. Code 36-7-4, 500 Series.
- Notification of the June 6, 2011 APC public hearing and June 20, 2011 approval and certification was provided in accordance with the APC Rules of Procedure and Ind. Code 36-7-4-507.



- On June 20, 2011 the APC approved and certified the Addendum (8-0) to the City Council for adoption.
- The City Council may adopt on this item on the June 27, 2011 meeting.

Summary

The proposed addendum to the Westfield Thoroughfare Plan, a part of the Comprehensive Plan, incorporates modifications to the street system around Grand Park, The Sports Campus at Westfield. The proposed changes will enhance traffic flow to and throughout the Grand Park economic development area.

Recommendations / Actions

The Westfield Community Development Staff, in its final reports to the APC recommended that the APC approve and certify the Addendum to the City Council for adoption.


**WESTFIELD-WASHINGTON ADVISORY PLAN COMMISSION
