

ORDINANCE 11-13

ORDINANCE OF THE CITY OF WESTFIELD TO EXTEND ORDINANCE 10-06 TO JULY 4, 2012

WHEREAS, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

WHEREAS, it is the duty and the responsibility of the Council to maintain the fiscal integrity of the finances of the City by maintaining appropriate fees for services performed by the City and to foster economic activity and growth by creating incentives and lessening obstacles for future development , and

WHEREAS, the Council from time to time may find it necessary to amend previously adopted ordinances to assure that the desired purposes are carried out as contemplated by the Council; and,

WHEREAS, the current sewer fees have been set and amended by ordinances 03-25 and 06-43 and the current water fees have been set and amended by ordinances 03-24, 06-44, 10-06 and 10-13; and,

NOW, THEREFORE, BE IT ORDAINED by the Westfield City Common Council meeting in session as follows:

Section 1. The Council now finds that an amendment of ordinance 10-06 is necessary to continue the economic incentives created by that ordinance.

Section 2. That Section 4 of ordinance 10-06 shall be replaced with the following:

“Notwithstanding any other provision and subject to future amendment, this Ordinance shall be become null and void on July 4, 2012.”

Section 3. That ordinance 10-06 shall be further amended to only apply to non-residential property.

Section 4. This Ordinance shall be in full force and effect in accordance with Indiana Law, upon its passage by the City Council, its publication in accordance with law and upon the passage of any applicable waiting period, all as

provided by the laws of the State of Indiana. All ordinances or parts thereof in conflict herewith are hereby ordered amended or repealed. If any part of this Ordinance is later held void, the remaining sections shall remain in place. All acts taken pursuant to the adoption of this Ordinance are hereby ratified.
