Notice is hereby given to the taxpayers of Westfield Civil City, Hamilton County, Indiana, that the proper officers of Westfield Civil City at 130 Penn Street, on September 26, 2011, at 7:00 p.m., will conduct a public hearing on the 2012 budget. Following this meeting, any ten or more taxpayers may object to a budget, tax rate, or tax levy by filing an objection petition with the proper officers of the political subdivision within seven days after the hearing. The objection petition must identify the provisions of the budget, tax rate or tax levy that taxpayers object to. If a petition is filed, the political subdivision shall adopt with its budget a finding concerning the objections filed and testimony presented. Following the aforementioned hearing, the fiscal body will meet at 130 Penn Street on October 10, 2011 at 7:00 p.m. to adopt the following budget.
