

RESOLUTION 11-19

A RESOLUTION OF THE CITY OF WESTFIELD AMENDING 2011 SALARY ORDINANCE

WHEREAS, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

WHEREAS, the Council has the authority and responsibility to adopt a salary ordinance as was done for 2011; and,

WHEREAS, from time to time adjustments are required that were not anticipated at the time of the adoption of the ordinance.

NOW, THEREFORE, BE IT RESOLVED by the Westfield City Common Council meeting in session as follows:

Section 1. Salary Ordinance 10-18 is hereby amended to include the following:

- a) Parks and Recreation Administrative Assistant is hereby added with an hourly rate of \$16.25 an hour.
- b) Parks and Recreation Maintenance Supervisor is hereby added with an hourly rate of \$22.32 an hour.
- c) Community Development Economic Development Director with an annual salary of \$62,857.60.
- d) Department of Administration Project Manager is hereby created with a bi-weekly salary of \$2404.00.

Section 2. That the Clerk Treasurer shall incorporate the changes into the City employee salaries as outlined.

Section 3. This Resolution does not create an additional expenditure beyond those anticipated by the 2011 budget. It shall grant the Director of those departments to create these positions and use their budgeted amounts

Section 4. This Resolution shall be in full force and effect immediately and remain in effect until further action by the Council. All acts undertaken in compliance with this Resolution prior to its adoption are hereby ratified.
