**ORDINANCE 11-12**

**AN ORDINANCE OF THE CITY OF WESTFIELD TO COMPLY WITH SEA 292/  
AMENDING I.C. 35-47-11**

**WHEREAS**, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, the Council has the duty and authority to maintain, review and revise the ordinances, rules, regulations and policies of the City; and,

**WHEREAS**, the Indiana Legislature has enacted SEA 292 creating a new section under Title 35 of the Indiana Code.

**NOW, THEREFORE, BE IT ORDAINED** by the Westfield City Common Council meeting in session as follows:

- Section 1.** That the Council recognizes the provisions of SEA 292 and its amendment to Title 35 of the Indiana Code, including but not limited, to I.C. 35-47-11 and a possible conflict with current ordinances, rules, regulations and policies within the City of Westfield.
- Section 2.** That as of the effective date of this Ordinance, all ordinances, rules, regulations and policies in conflict with and not pursuant to SEA 292 and its amendment to Title 35 of the Indiana Code, including but not limited to I.C. 35-47-11, are hereby void and of no effect.
- Section 3.** This Ordinance shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All ordinances or parts thereof that are in conflict herewith are hereby ordered repealed.
