

## ORDINANCE 12-08

### AN ORDINANCE OF THE CITY OF WESTFIELD CREATING A NEW FUND FOR THE DEPOSIT AND MANAGEMENT OF SUMS DERIVED FROM THE OPERATION OF THE WESTFIELD TRAINING CENTER

**WHEREAS**, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, the Council has the duty and authority to maintain and allocate funds as necessary from the duly adopted budget to maintain the fiscal integrity of the City and maximize efficiency; and,

**WHEREAS**, it has become necessary to create a new fund for the proper management of the City’s finances and the proper accounting of those sums derived from operation of the Westfield Training Center.

**NOW, THEREFORE, BE IT ORDAINED** by the Westfield City Common Council meeting in session as follows:

**Section 1.** That the Clerk-Treasurer is hereby authorized to create and maintain fund 269 for the deposit and management of all sums received from the operation of the Westfield Training Center for the City of Westfield.

**Section 2.** All funds shall be non-reverting and subject to any and all restrictions pursuant to the terms in place by any policy and procedure of the City of Westfield as well as any future order of the Council.

**Section 3.** This Ordinance shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All ordinances or parts thereof that are in conflict herewith are hereby ordered repealed.
