

ORDINANCE 12-47

**AN ORDINANCE PROVIDING FOR THE REDISTRICTING OF THE CITY OF
WESTFIELD, HAMILTON COUNTY, INDIANA, PURSUANT TO THE
REQUIREMENTS OF INDIANA CODE 36-4-6-4**

WHEREAS, the population of the City of Westfield has increased in unequal amounts among the voting districts as evidenced by the United States Census of 2010 and subsequent annexations, and;

WHEREAS, the City of Westfield is required by Indiana law to maintain equal population, as is possible in the voting districts pursuant to I.C. 36-4-6-4, and;

WHEREAS, the Westfield Common Council ("Council") has authority to divide the City into districts for the purpose of conducting elections pursuant to I.C. 36-4-6-4, and;

WHEREAS, to make the Council more reflective of the population of the City and to better represent the population of the City of Westfield, the voting districts must be amended, and;

WHEREAS, the plans for this redistricting has been reviewed and approved by the Hamilton County Election office.

NOW, THEREFORE, BE IT ORDAINED by the Westfield City Common Council meeting in session as follows:

SECTION 1.

As of the effective date of this Ordinance, the City of Westfield shall remain represented by seven (7) Council Members elected from five (5) election districts and two (2) at large elected by the entire City as evidenced and in conformity by Exhibit "A" attached hereto and incorporated by reference herein. Said split in any census block shall be pursuant to I.C. 36-4-6-4.

SECTION 2.

This Ordinance shall be in full force and effect in accordance with Indiana Law, upon its passage by the City Council, its publication in accordance with law, and upon the passage of any applicable waiting period, all as provided by the laws of the State of Indiana. All Ordinances or parts thereof in conflict herewith are hereby ordered repealed.
