

ORDINANCE 14-24

ORDINANCE FOR ADDITIONAL APPROPRIATION

WHEREAS, The City of Westfield, ("City") is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council ("Council"); and,

WHEREAS, it is the duty and the responsibility of the Council to maintain the fiscal integrity of the finances of the City and to use those finances to further that fiscal integrity of the City, and

WHEREAS, sometimes becomes necessary to appropriate additional funds within the approved budget as contemplated and authorized under I.C. 36-4-7-8 to maintain that fiscal integrity and foster economic growth for the City.

NOW, THEREFORE, BE IT ORDAINED by the Westfield City Common Council meeting in session as follows:

Section 1. That the Council finds that the funds are to be utilized pursuant to the goals stated in resolution 14-112.

Section 1. That the additional appropriation of \$2,500,000.00 non-tax derived dollars is hereby authorized to be transferred and appropriated as indicated below .

Section 2. That said amounts shall be distributed as follows:

From: Fund 101660 [Utility Proceeds]
To: Fund 101 [General Fund]

Section 3. Upon transfer to the General Fund, the Council further authorizes those funds transferred to the Westfield-Washington School Corporation pursuant to Resolution 14-112 to facilitate the sale of School property and relocation and improvement of athletic fields.

Section 4. This Ordinance shall be in full force and effect in accordance with Indiana law, upon the passage of any applicable waiting periods, all as provided by the laws of the State of Indiana. All ordinances or parts thereof that are in conflict herewith are hereby ordered repealed. All acts undertaken to create this Ordinance are hereby ratified.


