RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF WESTFIELD, INDIANA, APPROVING THE ORDER OF THE WESTFIELD PLAN COMMISSION AND THE AMENDMENT BY THE WESTFIELD REDEVELOPMENT COMMISSION OF THE DECLARATORY RESOLUTION FOR THE SOUTHSIDE ECONOMIC DEVELOPMENT AREA

WHEREAS, on July 9, 2013, the Redevelopment Commission (the "Commission") of the City of Westfield (the "City") adopted Declaratory Resolution No. 5-2013 (the "Original Declaratory Resolution") establishing the Southside Economic Development Area (the "Original Area") as an economic development area under Indiana Code 36-7-14 and Indiana Code 36-7-25 et seq., and all acts supplemental and amendatory thereto (collective, the "Act"); and,

WHEREAS, on February 2, 2015, the Commission adopted its Resolution No. 2-2015 (the "2015 Amendatory Declaratory Resolution"), amending the Original Declaratory Resolution as previously amended to remove certain parcels and portions of parcels from the Southside Economic Development Area; and

WHEREAS, the Commission submitted its 2015 Amendatory Declaratory Resolution and supporting data, as required by the Act, to the Westfield-Washington Township Plan Commission (the "Plan Commission") and on February 2, 2015, the Plan Commission adopted its Order Number 15-03 approving the 2015 Amendatory Declaratory Resolution and the revision of the Southside Economic Development Plan to remove certain parcels and portions of parcels identified in the 2015 Amendatory Declaratory Resolution; and

WHEREAS, the Commission proposes to further amend the Declaratory Resolution to remove from the Area and from the Southside Allocation Area certain parcels (the "Parcels"), as described in Exhibit A of Declaratory Resolution 12-2015 (2015 Amendatory Declaratory Resolution-2), all in accordance with Indiana Code Section 36-7-14-17.5; and

WHEREAS, the Parcels are located within the Area and within the Southside Allocation Area.

WHEREAS, on October 19, 2015, the Commission adopted its 2015 Amendatory Declaratory Resolution-2, further amending the Declaratory Resolution as previously amended, to remove certain parcels from the Area and from the Southside Allocation Area; and,

WHEREAS, the Commission submitted its 2015 Amendatory Declaratory Resolution-2 and supporting data, as required by the Act, to the Westfield-Washington Township Plan Commission (the "Plan Commission") and on November 2, 2015, the Plan Commission adopted

its Order Number 15-06 approving the 2015 Amendatory Declaratory Resolution-2 and the revision of the Plan to remove certain parcels identified in the 2015 Amendatory Declaratory Resolution-2; and

WHEREAS, the actions proposed by the 2015 Amendatory Declaratory Resolution-2 will produce a net reduction of the Southside Economic Development Area; and,

WHEREAS, in accordance with Indiana Code 36-7-14-16(b), the 2015 Amendatory Declaratory Resolution adopted by the Commission and the Order of the Plan Commission have been submitted to the Common Council for approval; and,

WHEREAS, after being fully advised in the matter,

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF
CITY OF WESTFIELD, AS FOLLOWS:**

SECTION I. The 2015 Amendatory Declaratory Resolution-2 is in all respects approved, ratified and confirmed by the Common Council of City of Westfield.

SECTION II. The Order of the Plan Commission, adopted on November 2, 2015, approving the 2015 Amendatory Declaratory Resolution-2 is in all respects approved, ratified and confirmed by the Common Council.

SECTION III. The revision of the Southside Economic Development Area and the revision of the Southside Economic Development Plan to remove certain parcels and portions of parcels from the Southside Economic Development Area each are, in all respects, approved, ratified and confirmed by the Common Council.

SECTION IV. The Clerk-Treasurer of the City of Westfield is hereby directed to file a copy of the 2015 Amendatory Declaratory Resolution-2 and the Order of the Plan Commission with the permanent minutes of this meeting.

SECTION V. This Resolution shall be in full force and effect immediately upon its adoption.
