



**ORDINANCE 16-15**

**ORDINANCE OF THE CITY OF WESTFIELD TO ALLOW FOR  
CREDIT CARD PAYMENTS**

**WHEREAS**, The City of Westfield, ("City") is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council ("Council"); and,

**WHEREAS**, the Council is responsible for the policies and procedures for the orderly collection of fees necessary to administer services to the public; and,

**WHEREAS**, there has been requests from the public to allow for the payment of certain fees to the City by credit cards; and,

**WHEREAS**, the use of credit cards will require the City to collect a convenience fee to be imposed for those desirous of making payments in that manner.

**NOW, THEREFORE, BE IT ORDAINED** by the Westfield City Common Council meeting in session as follows:

**Section 1.** The Council now being duly advised, finds that the sum of Two Dollars (\$2.00) is necessary for the City to offer the option of making payments by credit card. Council further finds that the fee is only adequate to cover the costs of administering this service.

**Section 2.** Any and all information required to be accumulated to allow for the credit card payments to be offered and administered by the City shall be a condition precedent to the acceptance of credit card payments.

**Section 3.** This Ordinance shall be in full force and effect in accordance with Indiana Law, upon its passage by the City Council, its publication in accordance with law and upon the passage of any applicable waiting period, all as provided by the laws of the State of Indiana. All ordinances or parts thereof in conflict herewith are hereby ordered amended or repealed. All acts taken pursuant to the adoption of this Ordinance are hereby ratified.
