

RESOLUTION 16-121

RESOLUTION TO SUPPORT THE WESTFIELD WASHINGTON SCHOOL CORPORATION

WHEREAS, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

WHEREAS, the City of Westfield believes the proposed operating referendum by Westfield Washington School Corporation (Schools”) will provide needed funding for academic and educationally related programs at current levels and maintain class sizes.

WHEREAS, the proposed referendum rate will not exceed the tax rate of twenty cents (\$0.20) on each one hundred dollars (\$100) of assessed valuation.

WHEREAS, the tax rate requested in this referendum will be lower than the rate approved by Westfield Washington Schools voters in 2010.

WHEREAS, education is consistently rated at the top of the list in factors considered by companies looking to locate or expand in our community.

WHEREAS, numerous studies demonstrate the correlation between a good school system, strong property values and overall community stability.

NOW, THEREFORE, BE IT HEREBY RESOLVED by the City Council of the City of Westfield meeting in regular session, as follows:

Section 1. The Council having considering the information herein and the fact the Schools have demonstrated sound financial management, the City of Westfield is pleased to endorse and support the 2016 school operating referendum.

Section 2. This Resolution shall be in full force and effect immediately, all acts necessary in the creation of this manual and amendments thereof are hereby ratified.
