FILINGS OF NOTE

- **Zoning Petitions:** Two (2) new Planned Unit Development (PUD) Districts: Wilshire PUD, proposed 86 lot single-family residential district on the north side of 156th Street, west of Spring Mill Road; West Rail at the Station PUD, a 186 lot single-family residential district at the northeast corner of 156th Street and Ditch Road.
- Hampton Inn received approval of its Detailed Development Plan, located in the House and Hall PUD District, rendering below.

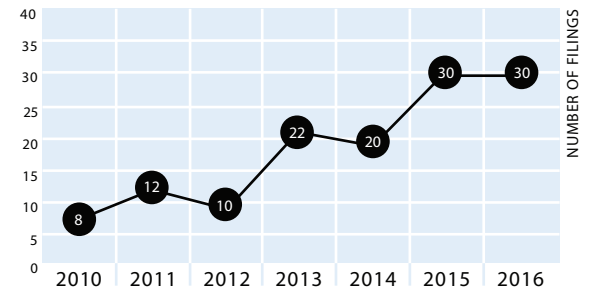


HAMPTON INN PROPOSED AT WHEELER ROAD, JUST SOUTH OF SR 32

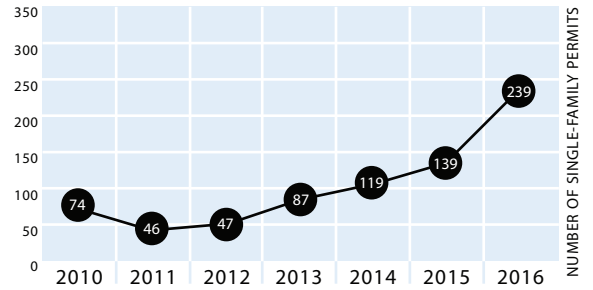
CITY OF WESTFIELD 1Q 2016 NOTABLE EVENTS

- Grand Park released the 2015 Economic Impact Report: In its second year of operations, the economic impact more than doubled from \$66.4 million in 2014 to \$147.7 million in 2015.
- The Village Farms Neighborhood Comprehensive Plan Amendment was adopted. This amendment will help ensure efforts and energies of the City and the Neighborhood are coordinated.
- A Consumer Affairs report named Westfield as one of the top ten safest cities in Indiana. The report, which uses data from the Census Bureau and FBI crime statistics, ranks Westfield at #7 in the state. Consumer Affairs is a consumer news and advocacy organization founded in 1998.
- The US Census Bureau began gathering data for an updated population count. This new count will help the City qualify for additional state revenues for essential services such as street repair and education.

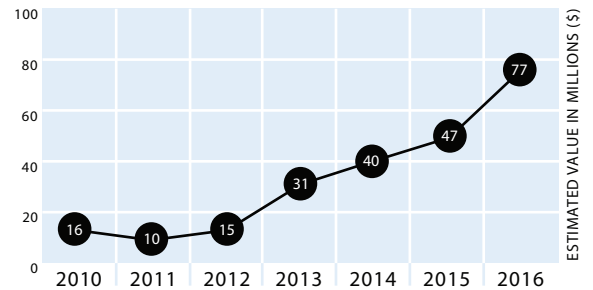
1Q ADVISORY PLAN COMMISSION FILINGS
