

## RESOLUTION 17-134

### A RESOLUTION OF THE CITY OF WESTFIELD ADOPTING AN AMENDMENT TO THE COMPREHENSIVE PLAN

**WHEREAS**, The City of Westfield, (“City”) is a duly formed municipal corporation within the State of Indiana, governed by its duly elected Mayor and Common Council (“Council”); and,

**WHEREAS**, the Council has the duty and authority to approve any and all changes to the Westfield-Washington Comprehensive Plan; and,

**WHEREAS**, it has become necessary to amend the Comprehensive Plan by the addition of a new and revised Zone Improvement Plan which was adopted and certified by the Westfield-Washington Advisory Plan Commission (“APC”) on November 6, 2017.

**NOW, THEREFORE, BE IT RESOLVED** by the Westfield City Common Council meeting in session as follows:

- Section 1.** The Council has reviewed the amendment to the Comprehensive Plan regarding the new Zone Improvement Plan and certified by the APC and hereby approves the same.
- Section 2.** This Resolution shall be in full force and effect immediately and remain in effect until further action by the Council.
