### **Petition History**

This petition to amend sections of the Westfield-Washington Township Zoning Ordinance was introduced at the December 13, 2010 City Council meeting. This petition received a public hearing at the January 4, 2011 Advisory Plan Commission meeting, and it received a unanimous favorable recommendation for approval at the January 18, 2011 Advisory Plan Commission meeting.

### **Procedural**

- Requests for amendments to the zoning ordinance are required to be considered at a public hearing, in accordance with Ind. Code 36-7-4-602.
- The Advisory Plan Commission (the "APC") held a public hearing on January 4, 2011 and issued a unanimous favorable recommendation (6-0) to the City Council in support of the proposed rezone request at its January 18, 2011 meeting.
- Notification of the January 4, 2011 public hearing was provided in accordance with the APC Rules of Procedure.
- The Westfield City Council may take action on this item at the February 14, 2011 meeting.

### **Review of Amendments**

The proposed changes to the Sign Standards (WC 16.08.010) include clarifying the when the Sign Standards apply; adding standards for commercial/noncommercial flags; clarifying the Maintenance and Repair requirements; adding provisions for Electronic Gas Price and Time/Temperature Signs; relocating the Window Signage standards within the ordinance; clarifying the sign area allocation for Individual

Nonresidential Signs; adding new Temporary Signs (Building/Developer Sequential Sign Collections and Ornamental Banners); clarifying the Nonconforming Sign section; and clarifying when a sign permit is required.

The proposed changes to the Lighting Standards (WC 16.07.010) are as a result of the newly proposed Electronic Sign standards.

The proposed changes to the Definitions (WC 16.04.210) are new terms that were used in creating the new language in the Sign Standards.

The City Council Subcommittee reviewed these amendments, and forwarded them the City Council and the APC with a favorable recommendation.

### **Recommendations/Actions**

- **Community Development Department [January 18, 2011]**  
The Westfield Community Development Staff, in its report to the APC, made a recommendation that the APC forward a favorable recommendation to the City Council.
  
- **Advisory Plan Commission [February 7, 2011]**  
The Westfield-Washington Advisory Plan Commission has forwarded a unanimous favorable recommendation to the City Council (Vote of: 6-0).

CERTIFICATION**


