

RESOLUTION NO. 19-107

A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF WESTFIELD, INDIANA APPROVING THE ESTABLISHMENT OF AN ECONOMIC DEVELOPMENT AREA AND ALLOCATION AREA AND APPROVING THE ECONOMIC DEVELOPMENT PLAN FOR THE ECONOMIC DEVELOPMENT AREA

WHEREAS, on March 18, 2019, the Westfield Redevelopment Commission (“Commission”), as the governing body for the City of Westfield Redevelopment Department (“Department”), pursuant to Indiana Code 36-7-14, as amended (“Act), adopted Resolution No. 01-2019 (“Declaratory Resolution”) designating an area known as the “Wheeler Landing Economic Development Area” (“Economic Development Area”) as an economic development area pursuant to Section 41 of the Act and designated the entire Economic Development Area as an allocation area pursuant to Section 39 of the Act; and

WHEREAS, the Declaratory Resolution also approved an economic development plan for the Economic Development Area (“Plan”); and

WHEREAS, the Westfield-Washington Plan Commission, on April 1, 2019, approved and adopted an order (“Order”) determining that the Declaratory Resolution and the Plan conform to the plan of development for the City of Westfield, Indiana (“City”) and approving the Declaratory Resolution and the Plan; and

WHEREAS, Section 16(b) of the Act requires the Common Council of the City of Westfield, Indiana (“Common Council”) to approve the Order of the Plan Commission; and

WHEREAS, Section 41(c) of the Act requires that the determination that a geographic area is an economic development area be approved by the Common Council;

NOW, THEREFORE, be it resolved and adopted by the Common Council of the City of Westfield, Indiana as follows:

- Section 1. Pursuant to Section 16(b) of the Act, the Common Council hereby approves, in all respects, the Declaratory Resolution, the Plan and the Order.
- Section 2. The Common Council hereby approves the determination that the Economic Development Area is an economic development area pursuant to Section 41 of the Act.
- Section 3. This Resolution shall be in full force and effect from and after its passage by the Common Council and approval by the Mayor as required by law.
