**ORDER OF THE WESTFIELD-WASHINGTON TOWNSHIP ADVISORY PLAN
COMMISSION DETERMINING THAT THE AMENDING DECLARATORY
RESOLUTION FOR THE EAST SIDE ECONOMIC DEVELOPMENT AREA AND THE
GRAND JUNCTION ECONOMIC DEVELOPMENT AREA APPROVED AND
ADOPTED BY THE WESTFIELD REDEVELOPMENT COMMISSION CONFORMS
TO THE COMPREHENSIVE PLAN AND APPROVING
THE AMENDING DECLARATORY RESOLUTION**

WHEREAS, the Westfield-Washington Township Advisory Plan Commission (the “Plan Commission”) is the body charged with the duty of developing a general plan of development for the City of Westfield, Indiana (the “City”);

WHEREAS, the Westfield Redevelopment Commission (the “Commission”), as the governing body for the City of Westfield Redevelopment Department (the “Department”), pursuant to Indiana Code 36-7-14, as amended (the “Act), on November 18, 2019, approved and adopted Resolution No. 09-2019 (the “Declaratory Resolution”) approving certain amendments to the declaratory resolution and economic development plan for each of the East Side Economic Development Area and the Grand Junction Economic Development Area as more particularly described therein (the “2019 Plan Supplements”);

WHEREAS, the Commission has submitted the Declaratory Resolution and the 2019 Plan Supplements to the Plan Commission for approval pursuant to the provisions of Section 16 of the Act; and

WHEREAS, in reviewing the 2019 Plan Supplements, the Plan Commission has determined that no residents of the City will be displaced by the proposed 2019 Plan Supplements; and

WHEREAS, the Plan Commission has reviewed the Declaratory Resolution and the 2019 Plan Supplements and determined that the Declaratory Resolution and the 2019 Plan Supplements conform to the plan of development for the City, and now desires to approve the amending Declaratory Resolution and the 2019 Plan Supplements.

NOW, THEREFORE, BE IT ORDERED BY THE WESTFIELD-WASHINGTON TOWNSHIP ADVISORY PLAN COMMISSION, AS FOLLOWS:

1. Pursuant to Section 16 of the Act, the Plan Commission hereby finds and determines that the Declaratory Resolution and the 2019 Plan Supplements conform, in all respects, to the plan of development for the City.

2. The Declaratory Resolution and the 2019 Plan Supplements are hereby approved. This Resolution hereby constitutes the written order of the Plan Commission approving the Declaratory Resolution and the 2019 Plan Supplements pursuant to Section 16 of the Act.

3. The Secretary of the Plan Commission is hereby directed to file a copy of the Declaratory Resolution, including the 2019 Plan Supplements with the minutes of this meeting.
